Join us on April 17, 2024, for a compelling session led by Prof. Renato Nazzini from King's College London, focusing on enhancing the efficiency of resolving construction disputes.

Construction disputes, known for their complexity, extensive documentary evidence, technical nature,

and often involving multiple parties, can lead to expensive and prolonged legal battles. This session aims to explore strategies for streamlining arbitration proceedings to save both time and expenses. Prof. Nazzini will offer insights into procedural and case management strategies that can be employed by the parties and the arbitral tribunal to handle construction disputes more effectively. The goal is to prevent arbitration where possible and, when necessary, to ensure that the proceedings—including submissions, evidence, and decision-making—is conducted in a manner that is both efficient and cost-effective.

Prof. Nazzini brings a wealth of experience as an arbitrator and counsel in international arbitration. With dual qualifications as an English Solicitor and Italian Advocate, his professional journey spans Europe, Africa, Asia, and America. He is an active member of the ICC Arbitration and ADR Commission in Italy, the ICC Task Force on Dealing with Corruption Issues in International Arbitration, and a Fellow of the Chartered Institute of Arbitrators.

工程爭議經常涉及大量的技術文件作為書面證據，也可能包含多個當事人，使得其本質相當複雜、爭議解決過程耗時且費用可觀。透過精簡的程序安排，則能有效節省當事人的時間與金錢成本。本講座將針對爭議解決與案件管理技巧提供介紹，期能提供當事人及仲裁人做為程序中的參考與指引；以避免爭議擴大為原則，但若必須交付仲裁，則透過程序設計確保用最有效率的方式完成書狀交換、證據(包括證人)調查、及仲裁庭裁決，使爭議解決成本降至最低。
